

Future Urban Leaders Sweepstakes

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The sweepstakes is open only to those who sign up at the sweepstakes page located at *futureurbanleaders.org/sweepstakes* and who are 18 as of the date of entry. The sweepstakes is only open to legal residents of *the United States of America* and is void where prohibited by law.
